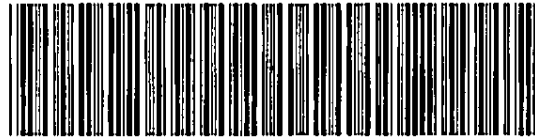

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION
OF
ADVENTHEALTH EAST FLORIDA, INC.
(a Florida not for profit corporation)

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, the undersigned corporation hereby certifies as follows:

1. The name of this corporation is AdventHealth East Florida, Inc. ("Corporation").
2. The Articles of Incorporation shall be amended by deleting the provisions of Article I ("Corporate Name") and inserting in its stead the following:

ARTICLE I - CORPORATE NAME

The name of the corporation is AdventHealth Palm Coast Parkway, Inc.

3. These Articles of Amendment were duly adopted by the Corporation's sole Member, Adventist Health System Sunbelt Healthcare Corporation, at a meeting held on December 9, 2021, consistent with Florida Statutes Sections 617.0701(4) and 617.0721(4) and consistent with Article XIII of the Articles of Incorporation. The number of votes cast by the sole Member for the amendments to the Articles of Incorporation was sufficient for approval. Article XIII of the Corporation's Articles of Incorporation grants only the Member the authority to amend the Articles of Incorporation of the Corporation, and therefore, members of the Board of Directors of the Corporation are not entitled to vote on amendments to the Articles of Incorporation so no vote of the Board of Directors of the Corporation was sought or obtained.

4. These Articles of Amendment shall take effect immediately upon filing with the Florida Department of State, Division of Corporation.
