A FLORIDA CORPORATION NOT FOR PROFIT**

**ARTICLE I
NAME**

The name of this Corporation will be the **PARTIDO DEL PUEBLO INC.**, hereinafter designated "PDP."

**ARTICLE II
NATURE**

PDP is organized as a Florida corporation not for profit, intended to be entitled to non-profit status under Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provisions of subsequent federal tax laws exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law, as established and when consistent with Article III below. It is also expressly provided that, notwithstanding any other provision of these Articles, upon the dissolution of the corporation, assets will be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code, or will be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of will be disposed of by the Circuit Court the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court will determine, which are organized and operated exclusively for such purposes.

ARTICLE III
PURPOSES

The general nature, objects and purposes of PDP will be to promote the goals and ideology of PARTIDO DEL PUEBLO, are to support, morally and financially, the opposition inside Cuba in their struggle to establish:

- a. the primacy of individual liberty and responsibility as the foundation of Cuba's future Common Good; and,
- b. the protection of private property, as essential to the full enjoyment of liberty and individual responsibility by the governed; and,
- c. the Rule of Law, subject to a constitution which protects the inalienable rights sanctified by the best of western tradition; and,
- d. a free market, open to competition, without price controls, as the most effective way to create wealth, provide for the common welfare and conduct commercial transactions; and,
- e. the supremacy of Civil Society constituted by free citizens, not subjects, who voluntarily and freely empower their government, as their servant, to protect their individual liberty, ensure equality before the law, domestic tranquility, and the Common Good; and,
- f. representative democracy as the only politically legitimate source of collective decisions; and,
- g. limited government, always served by public servants, totally obedient of the Law, and subject to the constant scrutiny of the governed; and,
- h. participation in good faith exchanges built on mutual respect and understanding; and,

venture; trust or other enterprise which he/she fines, amounts paid in settlement and reasonable expenses, including attorneys' fees, actually and necessarily incurred as a result of such action, suit or proceeding or any appeal therein, if such person acted in good faith in the reasonable interest of PDP, such action was in the best interest of the reasonable ground for belief that such action was unlawful. The termination of any such action, suit or proceeding by judgment, order, settlement, conviction or upon a plea of nolo contendere or its equivalent will not in itself create a presumption that any such director or officer did not act in good faith in the reasonable belief that such action was in the best interest of PDP or that he/she had reasonable grounds for belief that such action was unlawful.

- b. By or in the right of PDP to procure a judgement in this favor by reason of his being or having been a director or officer of PDP, or by reason of his being or having been a director, officer, employee or agent of any other corporation, partnership, joint venture, trust or other enterprise which he/she served at the request of PDP, against the reasonable expenses, including attorneys' fees, actually and necessarily incurred by him in connection with the defense or settlement of such action, or in connection with the defense or settlement of such action, or in connection with an appeal therein if such person acted in good faith in the reasonable belief that such action was in the best interest of PDP. Such person will not be entitled to indemnification in relation to matters to which such person has been adjudged to have been guilty of gross negligence or misconduct in the performance of his duty to PDP unless, and only to the extent that, the court, administrative proceeding is held will determine upon application that, despite the adjudication of liability but in view of all circumstances of the case, such person is fairly and reasonable entitled to indemnification for such expenses which such tribunal will deem proper.

ARTICLE XIII

TRANSACTION IN WHICH DIRECTORS OFFICERS AND MEMBERS ARE INTERESTED

- a. No contract or transaction between PDP and one or more of its directors or officers, or between PDP and any other corporation, partnership, association, officers are directors or officers, have a financial interest, will be invalid, void or voidable solely for this reason, or participates in the meeting of the Board or committee thereof which authorized the contract or transaction, or solely because his or their votes are counted for such purpose. No director or officer of PDP will incur liability by reason of the fact that he/she is or may be interested in any such contract or transaction.
- b. Interested directors may be counted in determining the presence of a quorum at a meeting of the Board or of a committee which authorized the contract or transaction.
- c. No part of the net earnings of PDP will inure to the benefit of any Member, Director or Officer of PDP or any private individual. Provided, however, that (i) reasonable compensation may be paid for services rendered by any Member, Director or Officer to or for PDP, and (ii) this provision will not prohibit the reimbursement of funds advanced to, for or on behalf of PDP by any Member, Director or Officer when said funds are advanced with the consent and knowledge of PDP, evidenced by the written approval of the majority of the Board, including, without limitation, transportation and other travel expenses.

ARTICLE XIV

DISSOLUTION OF PDP

- a. Upon dissolution of PDP, all of its assets, remaining after provision for creditors and payment of all costs and expenses of such dissolution, will be distributed to other non-profit corporation(s) devoted to similar goals.
