



#### ARTICLES OF INCORPORATION OF Agape Shelters & Homes, Inc. A FLORIDA NONPROFIT CORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

#### ARTICLE I NAME

The name of the corporation shall be: Agape Shelters & Homes, Inc.

#### ARTICLE II PRINCIPAL OFFICE
