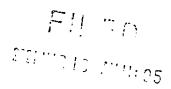

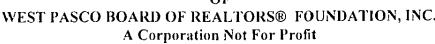

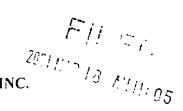

ARTICLES OF INCORPORATION OF





The undersigned incorporators, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I- NAME

The name of the corporation shall be "WEST PASCO BOARD OF REALTORS® FOUNDATION, INC."

ARTICLE II- PRINCIPAL OFFICE

The principal office and mailing address of the corporation, herein referred to as "Foundation," shall be 5409 Sunset Road, New Port Richey, FL 34652. The Board of Directors may, from time to time, change the address of the principal office of the Foundation and establish such additional location, within or outside of the State of Florida, as the Board shall determine, without prior notice to the members, or consent therefrom, and without requiring an amendment to these articles or Bylaws of the Foundation.

ARTICLE III- PURPOSES

This is a corporation not for profit which is being organized for Community Outreach, Charitable, and Educational purposes, and all other lawful purposes under the Florida Not for Profit Corporation Act, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future Federal Tax Code.

ARTICLE IV- BOARD OF DIRECTORS

The powers of the Foundation shall be exercised, its properties managed and controlled, and its business and affairs conducted by the Board of Directors. The manner in which the members of the Board of Directors are to be elected or appointed, and the terms and qualifications of Directors shall be as set forth in the Bylaws of the Foundation. The number of Directors shall be not less than three (3), but there shall be no maximum number. There shall be five (5) Directors initially, and said Directors shall hold office until their successors are qualified as provided in the Bylaws of the Foundation. ARTICLE V- MEMBERSHIP

The manner of election or appointment, and the qualifications of members shall be as set forth in the Bylaws; provided however no members shall have voting rights in the Foundation. All membership shall be nonvoting.

ARTICLE VI- REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the Foundation shall be 5409 Sunset Road, New Port Richey, FL 34652. The initial registered agent at said office shall be Sammie Copeland.

ARTICLE VII- INCORPORATION

ARTICLE VIII- COMMENCEMENT AND DURATION

The Foundation shall exist perpetually, and its existence shall commence at the time of the filing of these Articles with the Secretary of State of the State of Florida in the manner provided by law.

ARTICLE IX- ASSETS AND EARNINGS

Upon the dissolution of the Foundation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the internal Revenue Code, or corresponding section of any further Federal Tax Code. Any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction in the county in which the principal office of the Foundation is located, exclusively for such purposes or to such organization or organizations as such court shall determine, which are organized and operated exclusively for such purposes. No part of the earnings of the Foundation shall inure to the benefit of, or be distributed to, its members, officers, Directors, or any persons, except that the Foundation shall be authorized and empowered to pay reasonable

compensation for services rendered, and to make payments in the furtherance of the Foundation. Notwithstanding any other provisions of these Articles or of the Bylaws of the Foundation, the Foundation shall not carry on any activity not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1954, as amended, of the United States of America, or of any corresponding section of any further revenue code of the United States of America, or (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954, as amended, of the United States of America, or of any corresponding section of any future code of the United States of America.

ARTICLE X- AMENDMENT

These Articles of Incorporation may be amended from time to time by a vote of a majority of the Board of Directors at any regular or special meeting of the Board of Directors.
