## ATTACHMENT TO ARTICLES OF INCORPORATION FORM FOR KAHAL CHASIDIM OF SURFSIDE INC ARTICLE III: PURPOSE

H21000154558 3

This corporation is founded exclusively for charitable religious purposes within the meaning of the IRS Code Sec 501(c)(3); namely: To establish and maintain a House of Orthodox Jewish worship and there to provide Jewish religious, educational, cultural, social and all other helpful services to the Jewish community in Surfside FL and elsewhere. These services will include, but not be limited to, worship services, religious education classes, spiritual guidance, community outreach, inspirational events, celebrations, sacred feasts, works of charity, cultural or social activities as well as all manner of helpful services to the Jewish community. It will carry out its activities according to Torah-Halachic tradition contained in the Code of Jewish Law (Shulchan Aruch) by Rabbis Karo and Isserles and its commentaries and in the Chasidic tradition, all as understood by the synagogue's ritual committee. The initial ritual committee is composed of the directors and the president of the corporation. The ritual committee will seek out the advice and guidance of a recognized Rabbinic authority which whom they will consult when they find it necessary.

This corporation will be empowered to pay salaries or wages, as well as to rent or buy personal or real property, in order to carry out its activities. The corporation may, if the directors so choose, hire the services of a Rabbi and provide a parsonage for the Rabbi and his family. If a Rabbi is hired, he will serve at the behest of the Directors.

This corporation shall not, except in an insubstantial way, engage in any activities or exercise any powers that are not in furtherance of its charitable religious purposes. It will not attempt to influence legislation in any way or participate in political campaigns of any sort. No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to its directors, officers or any private person except that this corporation will be empowered to pay reasonable compensation for services rendered, to reimburse for expenses related to the carrying out of duties and make purchases of goods or services that are in furtherance of its exempt purposes.

This corporation is empowered to supply all the foods, religious items and physical constructions/properties required according to Orthodox Jewish Law and Chasidic Tradition, including Religious Articles, Kosher Food, Ritual Immersion Pools, or transportation to any event or location which in the view of the ritual committee is required for the fulfillment of religious duties as understood in Orthodox Jewish and/or the Chasidic tradition. Upon the dissolution of this corporation, the directors will –after clearing all debts and liabilities—distribute all remaining funds or assets to one or more organizations that have similar exempt purposes recognized under section 501(c) (3) of the Internal Revenue Code.
