

ARTICLES OF INCORPORATION

OF

CRONES' CRADLE CONSERVE FOUNDATION

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

ARTICLE I

Name

The name of the Corporation shall be Crones' Cradle Conserve Foundation, Inc (the "Foundation").

ARTICLE II

Principal Office

The principal place of business of the Foundation shall be:

ARTICLE III

Purpose

The purpose of the Foundation is

- 3.1 to preserve the real property for the purposes of conservation and restoration of the wildlife and their habitats, forests, wetlands, marshes, and other ecologically significant features thereon in their natural scenic open space, and wooded condition, and utilization of the land as a natural, aesthetic, scientific, and educational resource;
- 3.2 in the sole discretion of the Board, to conduct a feminist retreat center committed to the full cultural, economic, educational, ethnic, mental, physical, professional, racial, sexual, social, and spiritual equality of women and men, providing instruction in rural domestic arts such as palmetto frond weaving, quilting, storytelling, soap, and candle making, and offering opportunities for cultural, intellectual, social, and spiritual exploration; additional instruction will be added as needed:
- 3.3 in the sole discretion of the Board, to maintain an organic farm for the purposes of propagating vegetables, fruits, flowers, herbs, and those other plants indigenous to the

Southeastern United States, especially Florida; teaching sustainable and ecologically sound growing procedures; and demonstrating alternative agricultural methods suitable for "backyard" gardens, so as to encourage and nourish environmentally beneficial land use throughout the state and region. We shall also provide instruction in alternative agricultural methods in (a) sustainable soil composition, (b) companion planting, (c) no till soil preparation, (d) regenerative agriculture; and (e) carbon storage importance. Additional instruction added as needed

ARTICLE IV

Manner of Election

The method of election of the directors of the Foundation is set forth in the bylaws.

<u>ARTICLE VI</u>

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation,

contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any federal tax code.

ARTICLE VII

Dissolution

In the event of dissolution of the Foundation, the residual assets of the Foundation shall be distributed to one or more organizations that themselves are exempt from federal income taxation as organizations described within the meaning of Section 501(c)(3) of the Internal Revenue Code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by the Circuit Court for the County in which the principal office of the Foundation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VIII
