

We are in receipt of your Feb. 22nd email (Letter Number: 210222043106-300360607513) regarding our request to dissolve the corporation "New Earth Christian Ministries, Inc" and then reinstate the corporation using the same name and maintaining the same officers. Your letter reads "The name designated in your document is unavailable because it is the same as or not distinguishable from the existing entity" and if the principals are the same in both entities advise of this association.

We received incorrect information, no fault of the State of Florida, that to request a 501C3 status we first had to dissolve the existing corporation.
