ARTICLES OF INCORPORATION

MAYFLOWER WAY SECTION IV CONDOMINIUM ASSOCIATION, INC.

Pursuant to Chapter 617, Florida Statutes, the undersigned, as Incorporator, creates these Association Articles of Incorporation for the purposes set forth below. The Association shall also be governed by Chapter 718, Florida Statutes.

ARTICLE I

NAME: The name of the corporation, herein called the "Association", is Mayflower Way Section IV Condominium Association, Inc., and its address is c/o Pulte Home Company, LLC, 24311 Walden Center Drive, Suite 300, Bonita Springs, FL 34134.

ARTICLE II

DEFINITIONS: The definitions set forth in the Declaration of Condominium for Mayflower Way Section IV, a Condominium shall apply to terms used in these Association Articles.

ARTICLE III

PURPOSE AND POWERS: The purpose for which the Association is organized is to provide an entity pursuant to the Condominium Act for the operation of Mayflower Way Section IV, a Condominium, located in Collier County, Florida. The Association is organized and shall exist on a non-stock basis as a corporation not for profit under the laws of the State of Florida, and no portion of any earnings of the Association shall be distributed or inure to the private benefit of any member, Director or officer. For the accomplishment of its purposes, the Association shall have all of the common law and statutory powers and duties of a corporation not for profit under the laws of the State of Florida and of a condominium association under the Condominium Act, except as expressly limited or modified by the Association Documents; and it shall have all of the powers and duties reasonably necessary to operate the Condominium pursuant to the Association Documents as they may hereafter be amended, including but not limited to the following:

(A) To make and collect Association Assessments against members of the Association to defray the costs, expenses and losses of the Association, and to use the funds in the exercise of its powers and duties.

(B) To protect, maintain, repair, replace and operate the Condominium Property and Association Property.

(C) To purchase insurance for the protection of the Association and its members.

(D) To repair and reconstruct improvements after casualty, and to make further improvements of the Condominium Property.

(E) To make, amend and enforce reasonable Association Rules and Regulations in the manner set forth in the Association Bylaws and subject to any limitations in the Declaration of Condominium.

(F) To enforce the provisions of the Condominium Act and the Overall Governing Documents.

(G) To contract for the management and maintenance of the Condominium and the Condominium Property, and to delegate any powers and duties of the Association in connection therewith except such as are specifically required by law or by the Declaration of Condominium to be exercised by the Association Board of Directors or the members.

(H) To employ accountants, attorneys, architects, and other professional personnel to perform the services required for proper operation of the Condominium.

(I) To borrow money as necessary to perform its other functions hereunder.

(J) To grant, modify or move any easement in the manner provided in the Declaration of Condominium.

(K) To acquire, own, lease and dispose of any real and personal property.

(L) To sue and be sued.

All funds and the title to all property acquired by the Association shall be held for the benefit of the Members in accordance with the provisions of the Association Documents. In the event of termination, dissolution or final liquidation of the Association, the responsibility for the operation and maintenance of the Condominium Property and Association Property, including any property or easements and related improvements that are dedicated to the Association by plat, shall be transferred to and accepted by an entity that is acceptable to any applicable governmental authorities, prior to such termination, dissolution or liquidation.

ARTICLE IV

MEMBERSHIP:

(A) The members of the Association shall be the record Owners of a fee simple interest in one or more Units in the Condominium, as further provided in the Association Bylaws.

(B) The share of a member in the funds and assets of the Association cannot be assigned or transferred in any manner except as an appurtenance to his Unit.

(C) The Owners of each Unit, collectively, shall be entitled to one vote in Association matters. The manner of exercising voting rights shall be as set forth in the Association Bylaws.

ARTICLE V

TERM: The term of the Association shall be perpetual.

ARTICLE VI

BYLAWS: The Association Bylaws may be altered, amended, or rescinded in the manner provided therein.

ARTICLE VII

DIRECTORS AND OFFICERS:

(A) The affairs of the Association shall be administered by the Association Board of Directors consisting of the number of Directors determined by the Association Bylaws, but not less than three (3) Directors, and in the absence of such determination shall consist of three (3) Directors.

(B) Directors shall initially be appointed by and shall serve at the pleasure of the Condominium Developer. On the Association Turnover Date and thereafter, Directors shall be elected by the Members in the manner determined by the Association Bylaws. Directors may be removed and vacancies on the Association Board of Directors shall be filled in the manner provided by the Association Bylaws.

(C) The business of the Association shall be conducted by the officers designated in the Association Bylaws. The officers shall be elected each year by the Association Board of Directors at its first meeting after the annual meeting and they shall serve at the pleasure of the Association Board of Directors.

ARTICLE IX

AMENDMENTS: Amendments to these Association Articles shall be proposed and adopted in the following manner:

(A) Proposal. Amendments to these Association Articles may be proposed by the Association Board of Directors.

(B) Vote Required. Prior to the Association Turnover Date, these Association Articles may be amended by the Association Board of Directors. On and subsequent to the Association Turnover Date, a proposed amendment shall be adopted if it is approved by at least two-thirds (2/3) of the Voting Interests. As long as the Condominium Developer offers Units for sale in the ordinary course of business, no amendment to these Association Articles shall be made which is detrimental to the Condominium Developer's sale of Units, without the Condominium Developer's prior written consent, which consent may be denied in the Condominium Developer's discretion.

(C) Certificate; Recording. An amendment shall become effective upon filing with the Secretary of State and recording a Certificate of Amendment in the Public Records of Collier County, Florida, with the formalities required by the Condominium Act.

ARTICLE X

INDEMNIFICATION: To the fullest extent permitted by Florida law, the Association shall indemnify and hold harmless every Director, officer and committee member of the Association against all expenses and liabilities, including attorney fees, actually and reasonably incurred by or imposed on him in connection with any legal proceeding (or settlement or appeal of such proceeding) to which he may be a party because of his being or having been a Director, officer or committee member of the Association. In the event of a settlement, the right to indemnification shall not apply unless the Association Board of Directors approves such settlement as being in the best interest of the Association. The foregoing rights of indemnification shall be in addition to and not exclusive of all other rights to which a Director, officer or committee member may be entitled, but such rights shall not be available if a judgment or other final adjudication establishes that his actions or omissions to act were material to the cause adjudicated and involved:

(A) Willful misconduct or a conscious disregard for the best interests of the Association, in a proceeding by or in the right of the Association to procure a judgment in its favor,

(B) A violation of criminal law, unless the Director, officer or committee member had no reasonable cause to believe his action was unlawful or had reasonable cause to believe his action was lawful.

(C) A transaction from which the Director, officer or committee member derived an improper personal benefit.


