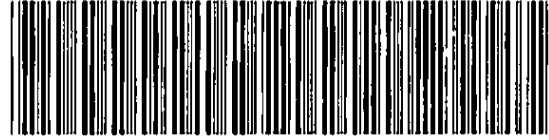

ADDING THE FOLLOWING ARTICLES TO THE ORIGINAL ARTICLES OF INCORPORATION:

ARTICLE IX - LIMITATIONS - The Florida Civil Rights Museum has a corporate purpose, which shall be organized exclusively for charitable, religious, educational, and scientific purposes including those that qualify as exempt under Section 501(c)(3) of the Internal Revenue Code.

ARTICLE X - DURATION - The corporation shall have perpetual existence. Corporate existence shall commence on the

date of the filing of these Articles of Incorporation with the Florida Division of Corporations.

ARTICLE XI - DISSOLUTION - Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code for a public purpose.
