## ARTICLES OF INCORPORATION OF Broken But Not Destroyed Ministries, Inc. A FLORIDA NONPROFIT CORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

#### **ARTICLE 1 NAME**

The name of the corporation shall be: Broken But Not Destroyed Ministries, Inc.

#### ARTICLE II PRINCIPAL OFFICE
