ARTICLES OF INCORPORATION OF A FLORIDA NONPROFIT CORPORATION

Article 1. Name of the Corporation is: Love My Brother, Inc

Article 2. <u>Duration:</u> The duration of the Corporation is perpetual.

Article 3. Purpose: The purpose of the corporation is as follows:

A. This Corporation is a not-for-profit corporation organized under Chapter 617, Florida Statues. It is not organized for the private gain of any person.
