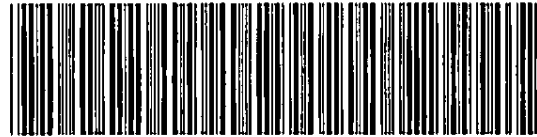

The organization that receives the assets of Sports, Fitness, and Education Inc. shall be selected by the Board Members of Sports, Fitness, and Education Inc.


