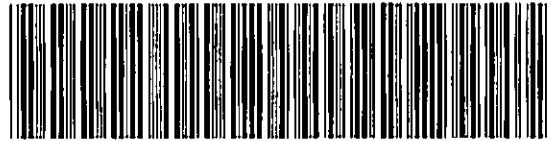





# **ARTICLES OF INCORPORATION**

## **OF XOBELL MINISTRIES, INC.,**

### **A NON-PROFIT FLORIDA CORPORATION**

The undersigned Incorporator, for the purpose of forming a Non-Profit Corporation pursuant to Chapter 617 et. seq., of the Florida Statutes, hereby adopts the following Articles of Incorporation:

#### **ARTICLE ONE**

The name of the corporation is: XOBELL MINISTRIES, INC.

#### **ARTICLE TWO**

The principal place of business and mailing address is: 2223 College Street, Suite 4. Jacksonville, Florida 32204.

#### **ARTICLE THREE**

A. The corporation is organized exclusively for charitable, religious, and educational purposes under section 501(c) (3) of the United States Internal Revenue Code, or corresponding section of any future federal tax code. The activities of the corporation are limited to those that comply with section 501(c) (3) of the United States Internal Revenue Code, or corresponding section of any future federal tax code.

B. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes described in section 501(c) (3).

C. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE FOUR**

A. The charitable and educational Mission and purposes for which this corporation is organized are the following:

1) To Create American Jobs and America Businesses for:

- a) Disabled Veterans and Veterans,
- b) Rehabilitating State and Federal Prisoners,
- c) Rehabilitating Alcoholics and Drug Addicts,
- d) High School and College Students,
- e) Single Mothers and Fathers with Children.
- f) All Persons in Need of a Second Income.

2) By training and educating such persons in leather crafting and other lawful business endeavors and by entering into a business relationship with them in a part time or full time home business or other type business.

3) To assist such persons in all of their spiritual, legal, medical and financial difficulties in every reasonable way.

B. The religious Mission and purposes for which this corporation is organized are the following:

1) To Educate And Teach Christian Principles By:

a) Preventing poverty and preventing crime in every reasonable way through education and the teaching of Christian principles and Christian values to such persons through the renewing of their minds by reading and understanding the Bible and through the practice of prayer to God. To accomplish these goals by utilizing the media and any other communication method.

b) Assisting such persons in every reasonable way in their "rehabilitation", whether the person is a Christian believer or a person of other Godly beliefs or a person who has no belief in God, and particularly to those persons who have plead guilty or who have been convicted of a crime or crimes, or who have been wrongfully convicted.

c) The definition and meaning of the term "every reasonable way" stated herein shall include such a broad definition and meaning as to be determined in the "sole discretion" of the corporation. The implementation of such definition and meaning to any set of facts shall also be determined by the "sole discretion" of the board of directors of the corporation.

## **ARTICLE FIVE**

This corporation shall be a charitable corporation and there shall be no less than three Directors of the corporation who are elected in accordance with its By-Laws.

## **ARTICLE SIX**

The names and addresses of the initial board of directors of the corporation are as follows: Ellis E. Neder, Jr., 2223 College Street #3, Jacksonville, FL 32204; Frank Green, 2223 College Street #1, Jacksonville, FL 32204; and Amelia Green, 2223 College Street #4, Jacksonville, FL 32204.

### **ARTICLE SEVEN**

This corporation shall commence existence upon the date of filing with the Department of State, Division of Corporations, state of Florida.

### **ARTICLE EIGHT**

The name and street address of the initial Registered Agent of this corporation shall be: Ellis E. Neder, Jr., 2223 College Street, Suite 4, Jacksonville, Florida 32204.

### **ARTICLE NINE**




