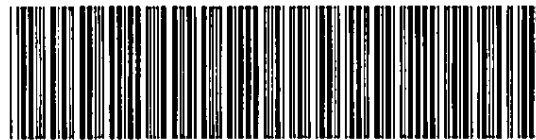



ARTICLE III PURPOSE
