#### **ARTICLE III – PURPOSE:**

The general purposes for which this Foundation has been established are as follows:

- To operate exclusively for such charitable, scientific and education purposes as will qualify
  it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954
  (the "Code"), as amended or under any corresponding provisions of any subsequent
  federal tax laws, covering the distributions to organizations qualified as tax exempt
  organizations under the Code, as amended, including private foundations and private
  operating foundations.
- 2. No part of the net earnings of the Foundation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the Foundation shall be authorized or empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this article. No substantial part of the activities of the Foundation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the Foundation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
- 3. To carry out all kinds of charitable activities, promoting solidarity and raising resources, to strengthen the initiatives and charitable works with the values of the Society of Jesus.
- 4. To provide education and integral formation, promoting exchange programs between countries, where the Jesuit Order develops spiritual and social work.
- 5. To establish and develop research programs in religious studies.
- 6. To promote the practice of the social mission in accordance with the values of the Jesuit Order through cultural and educational events and seminars.
- 7. To coordinate and promote a wide network of alumni, friends, benefactors, volunteers, institutions and companies that are committed to integral education which will have as main objectives:
  - i. To create a network of alumni and friends in the United States.
  - ii. To offer a fundraising platform through campaigns, activities and charity events.
  - iii. To promote a culture of solidarity and co-responsibility, inviting others to support with talents, resources and ideas.

- 8. To promote a model of education that prepares low-income students to be eligible to participate in exchange programs with other educational institutions in the United States.
- 9. To provide information about educational projects, works and achievements of the Society of Jesus to its alumni and friends residing in the United States.
- 10. To promote inter-institutional relations between educational institutions in Venezuela and in the United States to allow academic exchange and the development of joint projects of training and research.
- 11. To obtain contributions to expand scholarship funds and finance institutional development projects and acquire high quality supplies, materials and technologies in the United States.
- 12. To strengthen the management and sustainability of the Jesuit service mission, through strategies that respond effectively to the apostolic priorities of the mission.
- 13. Upon dissolution of the Foundation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Foundation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
- 14. In addition, this Foundation has been formed for the purpose of performing all things incidental to, or appropriate in, the foregoing specific and primary purposes. However, the Foundation shall not, except to an insubstantial degree, engage in any activity or the exercise of any powers which are not in furtherance of its primary non-profit purposes.
- 15. The Foundation shall hold and may exercise all such powers as may be conferred upor any nonprofit organization by the laws of the State of Florida and as may be necessary or expedient for the administration of the affairs and attainment of the purposes of the Foundation. At no time and in no event shall the Foundation participate in any activities which have not been permitted to be carried out by a Foundation exempt under Section 501(c) of the Code.
