

ARTICLE OF INCORPORATION A NONPROFIT, FLORIDA CORPORATION

ARTICLE I – CORPORATE NAME

Rosamond Johnson Jr. Family Foundation Inc.

ARTICLE II – CORPORATE NATURE

This is a nonprofit corporation, organized solely for general charitable purposes pursuant to the Florida Corporations Not for profit Florida Law set in Part I of Chapter 617 of the Florida Statutes.

ARTICLE III – GENERAL AND SPECIFIC PURPOSE

Section One Rosamond Johnson Family Foundation Inc. Is organized and shall be operated exclusively for charitable, religious, Educational and scientific purpose, including, for such purpose, the making of distributions to organizations that qualify as exempt Organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, community development and other related purposes, including, but not limited to, sponsoring, organizing, administering, enhancing and operating activities for the benefit of Escambia County & City of Pensacola, Florida and surrounding communities.

Section Two. Rosamond Johnson Jr. Family Foundation Inc. Is a not-for-profit corporation organized under Chapter 617, Florida Statutes. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its directors or officers, except to the extent permissible under the Articles of Incorporation and Bylaws, under law and under 26 U.S.C.A. § 501(c)(3) of the Internal Revenue Code. No private individual shall have any vested right, interest or privilege in or to the assets, income, or property of the Corporation and no part of the income or assets of the Corporation shall be distributable to or for the benefit of private individual, except to the extent permissible under the Articles of Incorporation, Bylaws, under law and under 26 U.S.C.A. § 501(c)(3) of the Internal Revenue Code.

ARTICLE IV - COMENCEMENT AND DURATION

The corporation is to commence it corporate existence on the date of subscription and acknowledgement of these articles of incorporation and shall exist perpetually thereafter until dissolved according to law.


ARTICLE IX – DISTRIBUTION OF ASSETS






