Articles of Incorporation of

RIVERSTATION Inc.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: We will be a floating research platform. We will collect data 24/7 and use the data to develop methods, systems, and technologies to improve the health of the River. We also want to allow humans to live on the river in a way that is beneficial to nature and humans. We will be open to the public and will share all data for free. Schools may bring students for exciting field trips. Our labs and facilities will be available to all scientists and researchers. Any person who wishes to participate is welcome. We will attempt to become entirely self-sufficient by growing all food, generating electricity, desalinating water, etc. We will have a state-of-the-art medical lab which can handle any medical needs and will be available for emergency care for injured boaters. We will also have multiple telescopes for astrological research. We will be construed using a modular design of my own which is inspired by the international space station. It can be construed and assembled and function in a harsh environment. Modular system allows us to start as a small platform and will get larger as more modules are added. We will have multiple live streaming cameras for anyone to watch 24/7.

Upon the dissolution of this corporation, assets remaining shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
