The undersigned Incorporator hereby files these Articles of Incorporation in order to form a non-profit corporation (the "Non-Profit Corporation") under the laws of the State of Florida.

**ARTICLE I.**

Every Director and employee of the Non-Profit Corporation shall be indemnified by the Non-Profit Corporation against all expenses and liabilities, including counsel fees and costs, reasonably incurred by or imposed upon him/her in connection with any action or proceeding to which he/she may be made a part, or in which he/she may become involved by reason of his/her being or having been a Director or employee at the time such expenses are incurred, except in such cases where there was or is malfeasance or misfeasance or as otherwise limited by law in the performance or omission of such duties as give rise to the subject of such action or proceeding. The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such Director or employee is or may be entitled. The Non-Profit Corporation shall indemnify the Legal Counsel from and against any claims brought by third parties, including counsel fees and costs, reasonably incurred by or imposed upon him/her in connection with any action or proceeding to which he/she may be made a part, or in which he/she may become involved by reason of his/her being or having been the Legal Counsel at the time such expenses are incurred, except in such cases whether there was or is malfeasance or misfeasance or as otherwise limited by law in the performance or omission of such duties as give rise to the subject of such action or proceeding.

**Amendment**

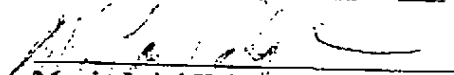
These Articles of Incorporation may be amended in any manner now or hereafter provided for by law, by majority vote of the Board of Directors.
