ARTICLES OF INCORPORATION

OF

Non-Profit Corporation

The undersigned incorporator, a natural person 18 years of age or older, for the purpose of forming a corporation under and pursuant to Chapter 617, F.S. of the Laws of the State of Florida and do hereby associate as a body corporate and adopt the following Articles of Incorporation.

Article I


