## ARTICLES OF INCORPORATION OF A Flicker of Hope Foundation, Inc. A FLORIDA NONPROFIT CORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

#### ARTICLE I NAME

The name of the corporation shall be: A Flicker of Hope Foundation, Inc.
