

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S. (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

A SUFI MESSAGE OF LOVE HARMONY BEAUTY INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The corporation is organized Not For Profit, and the activities, objects and purposes of this corporation, and the uses to which the property of this corporation is dedicated shall be exclusively charitable, scientific and educational, within the meaning of Sections 501(c)(2)(3), 170(c)(2)(B) and 2055(a)(2) of the Internal Revenue Code of 1986, including the following:

A. To be a permanent resource to spread the knowledge of unity, the religion of love and wisdom, so that the bias of faiths and beliefs may of itself fall away, the human heart may overflow with love, and all hatred caused by distinctions and differences may be rooted out.

B. To discover the light and power latent in mankind, the secret of all religion, the power of mysticism, and the essence of philosophy, without interfering with customs or beliefs.

C. To help bring the world's two opposite poles, East and West, closer together by the interchange of thought and ideals, that the Universal Brotherhood may form of itself, and each shall meet with each beyond narrow national and racial boundaries.

D. To solicit and receive property and funds through contribution, gift, grant, devise, and bequest. To hold, administer and disburse funds and property for the five principal activities of the Sufi Movement: The Esoteric School of Inner Culture ("Sufi Order"), The Religious Activity

of the Movement ("Universal Worship"), The Section for Social Work ("World Brotherhood"), The Healing Activity of the Movement ("Spiritual Harmony"), and The Activity of Symbolic Inner Realization ("Zirat"). The corporation shall provide a vehicle through which individuals, families, businesses, and organizations can financially support community needs based upon the Sufi Movement. The funds and other property of the corporation may be used at the discretion of the Board of Directors to assist individuals, entities, or organizations, or in support of developing programs, in order to improve the general well being of the community without regard to race, color, or creed.

E. In general, to exercise such other powers which are now or hereafter conferred upon corporations organized not-for-profit under the Florida Not For Profit Corporation Act and other laws of the State of Florida, subject to such limitations and conditions as are or may become prescribed by law, including those powers necessary or incidental to the powers so conferred, subject to the further limitation and condition that only such powers shall be exercised as are in furtherance of the exempt purposes of organizations operating under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and the regulations promulgated thereunder as they now exist or as they may be hereafter adopted or amended, and will not carry on any activities not permitted to be conducted by a corporation exempt from federal income tax under said Section 501(c)(3) of the said Code, or by a corporation the contributions to which are deductible under Section 170(c)(2) of the said Code.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The corporation shall not have or issue any shares of stock and shall have no members, and in lieu of members shall have a Board of Directors as appointed from time to time by the method set forth in the Bylaws of the corporation. The number of directors shall not be less than three (3) and not more than fifteen (15), as determined by the Board of Directors at each annual meeting of the directors.




