### ARTICLE I: NAME

### ARTICLE II: PRINCIPAL OFFICE

The purpose for which the corporation is organized is:

Said corporation is organized exclusively for charitable and educational purposes, including, for such purposes, that are acceptable to be performed by exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
