



# Constitution of **Lion of Judha Church Inc**, legally known as ARTICLES OF INCORPORATION

## ARTICLE 1 – NAME

The name of this church shall be “**LION OF JUDHA CHURCH INC.**”.

This congregation is organized as a church exclusively for charitable, religious, and educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue code of 1986 (or to the corresponding provision of any future United States Revenue Law).

## ARTICLE 3 – PURPOSE

We are Builders of God’s Kingdom. We draw our action from the direction Jesus gave His disciples in the Great Commission (Matthew 28:18-20).

LC is a house of the Lord where people experience reconciliation with God through the Gospel of Jesus Christ, and then carry that reconciliation into the world, one relationship at a time through word and deed (2 Corinthians 5:17-20).

## ARTICLE 4 – STATEMENT OF FAITH

This church receives the Bible and its teachings as the all-sufficient basis of doctrine and practice.

We believe in the triune God, who is eternally one God in three persons; Father, Son and Holy Spirit (Matthew 3:16-17 and John 14:15-17).

We believe that salvation and eternal life is available to all who trust Jesus Christ as Savior and Lord (John 3:16 and Ephesians 2:8).

We proclaim the atoning death and resurrection of Jesus Christ as the only means of salvation (1 Corinthians 15:3-6).

## BIBLICAL AUTHORITY

We believe the Bible is the sufficient and final rule of faith and practice, and it is an open book for each believer to read and interpret responsibly for him/herself. We believe that the Bible is God’s revealed message to all and has final authority for us in all matters of Christian faith and practice. In particular it reveals to us the person and work of Jesus Christ, the Son of God, as the One whom we are to love, serve and obey.

We believe in religious liberty and that freedom in matters of religion is an inherent right of the human soul. Religious freedom means the unrestrained right of the individual to approach God. Baptists have no priests, save the Great High Priest, Jesus Christ.

### **RELIGIOUS LIBERTY**

We believe there should be a separation between the church and the state, and that there should be no levy of taxes instituted to support or aid in a particular faith or form of worship, nor should there be any action taken by government that might accord a special status, privilege or priority to any religious organization.

### **AUTONOMY OF THE LOCAL CHURCH**

We believe in independent self-rule of the church.

### **CHURCH COMPOSITION**

We believe this church is composed of believers in Christ who have made a public profession of their faith in Christ, been baptized by immersion, gather as a believer's church, share in the Lord's Supper and live their faith as visible saints.

### **ORDINANCES**

Baptism and the Lord's Supper are ordinances of the church and not a means of salvation. They are symbols of great truths taught in the Scriptures.

**SCRIPTURAL BAPTISM** is the immersion of the believer in water symbolizing the death, the burial, and the resurrection of Jesus. Grace is given where medical conditions do not allow immersion.

**THE LORD'S SUPPER** is an ordinance of the church and is observed in commemoration of the suffering and death of Christ and the expectation of His return.

## **ARTICLE 5 – MEMBERSHIP**

The membership of this church shall consist of active and inactive members as described in the church by-laws.

## **ARTICLE 6 - OFFICERS**

The officers of this church shall consist of a lead pastor, a board of elders, a board of trustees and a church moderator. This church gives authority to the Pastor to Open bank accounts, sign checks, purchases and other activities

## **ARTICLE 7 - TAX-EXEMPT PROVISIONS**

### **Handling of Finances**

No part of net earnings of the church shall give advantage to its members, officers, or other private persons. The church shall be authorized and empowered to pay reasonable compensation for the services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II of the Articles of Incorporation.

### **Dissolution or Final Liquidation of Church**

Upon the dissolution or final liquidation of the church, the officers shall make payment of final liabilities. All remaining assets will be disposed of only to tax-exempt organizations that agree with the church's Statement of Faith.

### **Non-Discrimination**

The church shall have a nondiscriminatory policy and, therefore, shall not discriminate against employment applicants, members, students, and others on the basis of race, color, or national or ethnic origin.

## **ARTICLE 8 – AMENDMENTS**

The church officers shall review and evaluate the Articles of Incorporation every three years unless a need arises for earlier review.

The Congregation may consider a motion to amend, modify or rescind the Articles of Incorporation, upon recommendation of the church officers. The vote shall be by written ballot.


