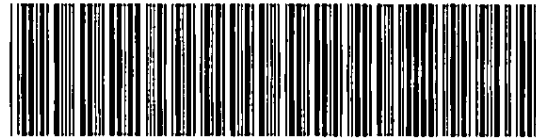


**MISERICORDIA CAREER AND TECHNICAL EDUCATION INC**

WHEREAS, the Directors and Member of MISERICORDIA CAREER AND TECHNICAL EDUCATION INC ("Misericordia") have determined that Misericordia's affairs should be wound up and the Corporation dissolved;

NOW, THEREFORE, the Directors and Member of Misericordia have adopted this PLAN OF DISTRIBUTION OF ASSETS ("Plan") and authorized this CERTIFICATE OF COMPLIANCE ("Certificate").

1. All liabilities and obligations of Misericordia shall be paid and discharged or adequate provisions be made therefor;
2. Assets held by Misericordia upon condition requiring return, transfer, or conveyance, which condition occurs by reason of the dissolution, shall be returned, transferred, or conveyed in accordance with such requirements;
3. Assets received and held by Misericordia subject to limitations permitting their use only for a charitable, religious, eleemosynary, benevolent, educational, or similar purpose, but not held upon a condition requiring return, transfer, or conveyance by reason of the dissolution, shall be transferred or conveyed to one or more domestic or foreign corporations, trusts, societies, or organizations engaged in activities substantially similar to those of the dissolving corporation, as provided in the Plan;
4. Other assets, if any, shall be distributed in accordance with the provisions of the Articles of Incorporation or the bylaws to the extent that the Articles or bylaws determine the distributive rights of members, or any class of members, or provide for distribution to others;
5. Any remaining assets shall be distributed to such persons, trusts, societies, organizations, or domestic or foreign corporations, whether for profit or not for profit, as specified in this Plan;
6. A copy of this Plan, authenticated by an officer of Misericordia and containing the officer's Certificate shall be filed with the Department of State.
7. Without limiting the foregoing:
  - a. All contracts of Misericordia have been concluded and settled;
  - b. All debts and liabilities of Misericordia have been settled and provided for;
  - c. All specifically designated funds of Misericordia have been returned;
  - d. All final costs and expenses of winding up the affairs of Misericordia have been provided for;
  - e. All remaining funds have been returned or distributed to an exempt organization engaged in educational activities.
