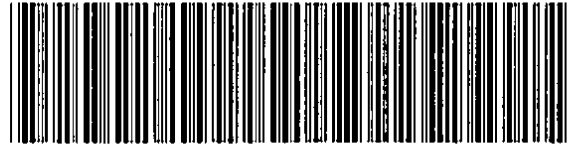

(Not for Profit)

Article I – Name

The name of the Corporation shall be Built the Life, Inc.

Article II – Address of Corporation

The principal address of the Corporation and the mailing address shall be:

Article III - Purpose

The specific purpose for which this Corporation is organized is to make housing available to low-income families and veterans within Palm Beach County, Broward County, and other areas of South Florida. The Corporation recognizes that affordable housing may not be readily accessible to low-income persons and veterans on the open market. In order to make such housing more readily accessible, the Corporation will endeavor to sell housing to low-income persons and veterans at affordable prices. Further, the Corporation will consider furnishing rental housing to low-income persons and veterans at affordable prices as well.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Article IV – Manner of Election

The manner in which the directors are to be elected or appointed shall be as stated in the bylaws of the Corporation.
