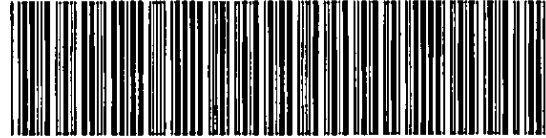

## **Crossroads Impact Church**

### **Florida Not for Profit Corporation**

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment(s) to its Articles of Incorporation:

### **Amendments Adopted**

**Please amend Article 3 to read as follows:**

#### **Article III. Purpose.**
