Pursuant to the provisions of Section 617.1006, Florida Statutes, The Florida Economic Development Council Foundation, Inc. (Document Number N21000008243), a Florida Not-for-Profit Corporation, adopts the following amendment to Article III of the Articles of Incorporation to amend the purpose. Such article shall hereafter read:

ARTICLE III

Purpose

The Corporation is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under section 501(c)(3) of the Internal Revenue Code (the "Code"), or corresponding section of any future federal tax code.

Notwithstanding any other provision of these Articles or of the Bylaws, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

There are no members entitled to vote on the amendment. The amendment was adopted by the Board of Directors on August 11, 2022.
