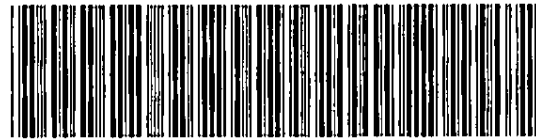

Amending Article III

Julia's Mission, Inc. is organized exclusively for charitable, religious, educational, and scientific purposes, including, for  
such purposes, making distributions to organizations under section 501(c)(3) of the internal revenue code or corresponding  
section of any future federal tax code. No part of the net earnings of Julia's Mission, Inc. shall inure to the benefit of, or be

empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this purpose clause.

#### Adding Article XIII

#### Article XIII - Dissolution Clause

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
