Please accept this notarized letter as proof of my recent voluntary dissolution and request to revoke, and then incorporate The WAY Academy as a non profit.

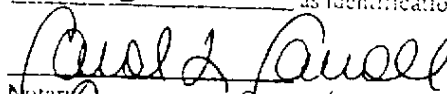

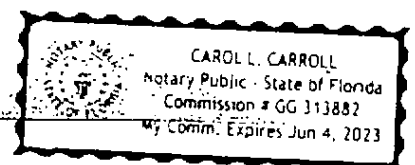
