## **ARTICLE III PURPOSE:**

The purpose for which the corporation is organized is:

Florida non-profit Corporation committed to the rescue, and adoption of domestic animals to their forever homes; rehabilitation and release of wildlife back into its natural habitat; To rescue, provide sanctuary for, or otherwise help, in any way the corporation may deem fit, any and all species of animals in need with a specialization in FELV positive cats and senior dogs. The Corporation will rescue and provide sanctuary for all animals in need that it can, this includes finding foster homes, adopting to forever homes, and providing a sanctuary for animals of all species (not to be limited in any way); and to Trap, Neuter/Spay, Vaccinate, and release feral cats in an effort to reduce the feline overpopulation in the Florida Panhandle. The Corporation will attempt to educate the community and raise awareness regarding TNR practices and how it works in reducing the feline population.

The purposes of the Corporation, as set forth in the Articles of Incorporation, are exclusively charitable, educational, or religious, within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future Federal tax law ("Section 501(c)(3)"). In furtherance of such purposes, the Corporation shall have the same powers as an individual to do all things necessary or convenient to carry out the purposes, as set forth in the Articles of Incorporation and these Bylaws.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
