ARTICLES OF INCORPORATION

THE OPEN CHAIR FOUNDATION, INC.

The undersigned, desiring to form a Not For Profit Corporation under the Not For Profit Corporation Law of Florida, Chapter 617, Florida Statutes (F.S.) hereby certifies:

Third: The organization is organized exclusively for charitable and educational purposes, including, for such purposes, but without limitation thereon, operating as a charitable foundation by receiving, investing, and administering assets, received as charitable gifts and contributions, and using such assets or the income therefrom to provide private care to individuals suffering from substance abuse and mental health disorders who are uninsured or unable to garner access to appropriate and adequate care. This Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purpose, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Solely for the above purposes, the organization is empowered to exercise all rights and powers conferred by the laws of the State of Florida upon Not For Profit Corporations, including, but without limitation thereon, the right and power to receive gifts, bequests and contributions outright, in trust or in any other form; and to use, apply, invest and reinvest the principal and/or income therefrom or to distribute the same for the above purposes.

Ninth: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Tenth: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the

principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
