This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for public and charitable purposes. The specific purpose of this corporation is: Educational and community outreach purposes specifically for the purpose of promoting the welfare of defense acquisition professionals for whom we are associated with.
