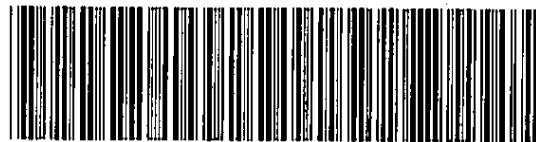

**ARTICLES OF INCORPORATION
OF
GIFTED MINDS ENRICHMENT CENTER, INC.**

A Florida Not for Profit Corporation

In Compliance with Chapter 617, F.S., (Not for Profit)

The undersigned, for the purpose of forming a Florida Not for Profit Corporation under the laws of the State of Florida, Florida Statutes 617, hereby adopts and executes the following Articles of Incorporation.

ARTICLE I

The name of this corporation shall be: **GIFTED MINDS ENRICHMENT CENTER, INC.** – a Florida corporation Not for Profit.

ARTICLE II

ARTICLE III

The corporation is organized exclusively for charitable, educational, and literary purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The corporation's purpose is to serve those who are disadvantaged, at risk, or underserved to reach their goals and become an integral part of society through educational enrichment programs. It will also assist individuals, community organizations, and special projects to address education, health, and human service needs, both locally and internationally.

The corporation shall not be conducted or operated for profit and no part of the net earnings of the corporation shall inure to the benefit of any individual, nor shall any of the profits or assets of the corporation be used other than for the purposes of the corporation.

ARTICLE IV

The manner in which the directors are elected or appointed is provided in the bylaws of the corporation.

ARTICLE V

The directors will be elected, maintained, and appointed in accordance with the corporation's bylaws. The corporation's initial directors are as follows:

ARTICLE VI

No officer or director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the officers or directors be subject to the payment of the debts or obligations of this corporation.

ARTICLE VII

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VIII

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of the section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed

to the federal government, or to a state or local government, for public purpose. Any such assets not so disposed shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are operated exclusively for such purposes.

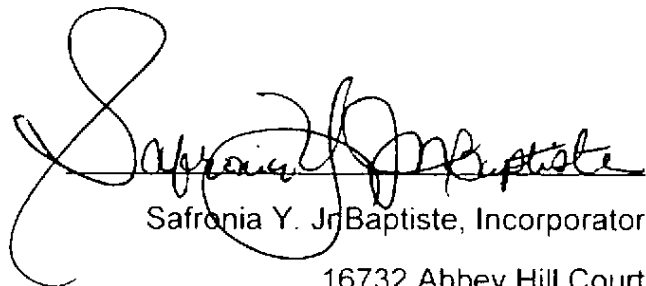
ARTICLE IX

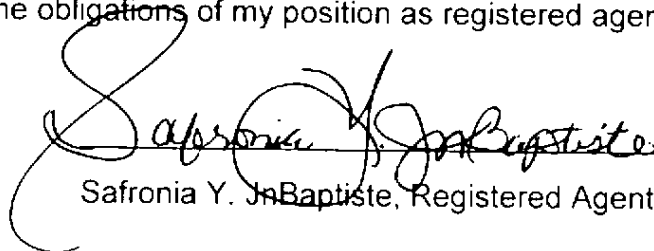
