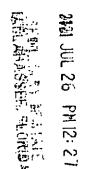

The purpose for which the corporation is organized:

To provide financial assistance to several different types of organizations which are exempt from federal income tax under Sections 501(c)(3) of the Internal Revenue Code of 1986, as amended, and to award scholarships and grants to financially needy individuals.
