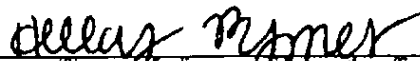

ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be:

ARTICLE II. PRINCIPAL OFFICE

ARTICLE III. PURPOSE(S)

The Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended ("Code").

ARTICLE IV. MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is set forth in the By Laws.

ARTICLE VII. CHARITABLE ORGANIZATIONS PROVISIONS

a. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for the services rendered and to make payments and distributions in furtherance of purposes set forth in the purpose clause hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.

b. Notwithstanding any other provision of this document, the organization shall not carry on any activities, directly or indirectly, which are not permitted to be carried on by or which would invalidate its status as (i) an organization exempt from federal income tax under Code Section 501(c)(3); or (ii) an organization contributions to which are deductible under Code Section 170(c)(2).

c. Upon dissolution of the Corporation or the winding up of its affairs, assets of this Corporation shall be distributed exclusively for one or more exempt purposes within the meaning of Code Section 501(c)(3), or shall be distributed to charitable, religious, scientific, or educational organizations that then qualify under the provisions of Code Section 501(c)(3) and the regulations issued thereunder, and no trustee, officer, director, or private individual shall be entitled to share in the distribution of any of the Corporation's assets.
