Attachment to Articles of Incorporation of JLP Ministries, Inc

This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for public and charitable purposes. The specific purpose of this corporation is: Ministry that will help food and clothing for persons who are unable to work, those that are less fortunate, help in disaster situation's, helping homeless veterans. We will help by praying, donations and giving.

This corporation is organized and operated exclusively for charitable purposes.
