## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF ZAHRADA II CONDOMINIUM ASSOCIATION, INC.

The Articles of Incorporation of ZAHRADA II CONDOMINIUM 1. ASSOCIATION, INC., a Florida not for profit corporation, were filed with the Florida Department of State on August 10, 2021.

2. Section 1 of Article I of the Articles of Incorporation is hereby deleted in its entirety and the following Section 1 inserted in lieu thereof:

Name and Principal Office. The name of the corporation "Section 1. shall be ZAHRADA 2 CONDOMINIUM ASSOCIATION, INC., a Florida not for profit corporation. For convenience, the corporation shall be referred to in these Articles as the "Association." The initial principal offices of the Association shall be located at 1819 Main Street, Suite 610, Sarasota, FL 34236."

3. In all other respects, the Articles of Incorporation of the corporation are ratified and affirmed in all respects.

These Articles of Amendment were approved by the Members of the 4. Corporation on December 2, 2021, and the vote of the Members was sufficient for approval.
