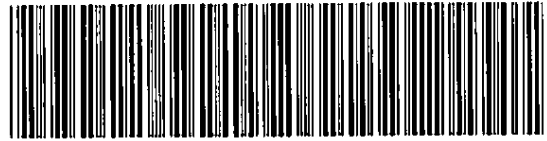

ARTICLES OF INCORPORATION FOR

AMATEUR GOLF ASSOCIATION – RED HILLS FL/GA, INC.

The undersigned incorporator hereby files these Articles of Incorporation for a non-profit company, as follows:

ARTICLE I

Name of Entity: The name of this entity will be Amateur Golf Association Red Hills FL/GA, Inc.

ARTICLE II

Effective Date of Incorporation: The effective date of this incorporation shall be the date of filing in the office of the Florida Department of State, Division of Corporations.

ARTICLE III

Existence of Entity: The entity will have perpetual existence.

ARTICLE IV

Manner in which Directors are Elected: Directors shall be elected as provided for in the Bylaws.

ARTICLE V

Principal Place of Business: The principal place of business of the entity is 1615 Village Square Blvd., Suite #7, Tallahassee, FL 32309.

ARTICLE VI

ARTICLE VII

Incorporator: The Incorporator is Claire A. Duchemin, 1615 Village Square Blvd., Suite #7, Tallahassee, FL 32309.

ARTICLE VIII

Corporate Purposes: The purposes of the entity are:

(A) The corporation is organized exclusively for not-for-profit purposes, including to connect women to learn, play, and enjoy the game of golf.

(B) No part of the net earnings of the corporation shall inure to the benefit of or be distributable to any Director, Officer, or member of the Corporation, or any other private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation, and reasonable expenses may be paid thereto, affecting one or more of the Corporation's purposes), and no Director or Officer of the Corporation, or any private individual shall be entitled to share in the distributions of any of the corporate assets upon dissolution of the Corporation. No substantial part of the activities of the Corporation shall include carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall neither participate nor intervene (including the publication or distribution of statements) in any political campaign on behalf of any candidate for public office, at any time.

(C) Notwithstanding any other provision of the Articles of Incorporation, the Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt under Section 501(c)(6) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.

ARTICLE IX

Initial Officers and Directors: The name and address of the initial director and President of the entity is Gayle Lee, P.O. Box 228, Tallahassee, FL 32302. The name and address of a second initial director and the Treasurer is Lisa Spooner, P.O. Box 228, Tallahassee, FL 32302. The name and address of a third initial director and the Secretary is Claire A. Duchemin, 1615 Village Square Blvd., Suite #7, Tallahassee, FL 32309.

Members: The Corporation shall have voting members as set forth in the Corporation's By-Laws.

ARTICLE X

Dissolution of Entity: Upon the dissolution of the Corporation, the winding up of its affairs, or the termination of the Affiliation Agreement with The LPGA Foundation, Inc. (the "Foundation"), the assets of the Corporation shall be distributed exclusively to The Foundation, which is exempt from Federal tax under §501(c)(3) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.
