Amending Article III Purpose -

THE HUSTLE AND HEART FOUNDATION, INC. is organized exclusively for charitable, religious, educational, and
scientific purposes including, for such purposes, making distributions to organizations under section 501(c)(3) of the internal
revenue code, or corresponding section of any future federal tax code. No part of the net earnings of THE HUSTLE AND
HEART FOUNDATION, INC., shall inure to the benefit of, or be distributable to its members, trustees, officers, or other

private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on by any 501(c)(3) organization, or any corresponding section of the Internal Revenue Code, or by any organization, contributions to which are deductible under section 107(c)(2) of the Internal Revenue Code, or corresponding section of any future tax code.

Adding Article VIII

Article VIII - Dissolution Clause

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
