

## **Attachment to Articles of Incorporation of Woman Retarded Corporation**

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows:

**To provide housing, with only towards approved, application. By obtaining money donations: By using of a Bake Sale method, to receive donations. Marketing for individuals to donate for; First month rents and 1st time down payments for housing. And, with approval, from written life essay and application; to determine who receives funding when funding is available; My charity would also be able towards giving, a month's rent for assistance; For only, WOMAN, being retarded; which haves up to a 2 month per year application difference of being able to able twice for a purpose of uplifting depressed and retarded women. And a difference; from a down payment application's approval; upon available cash assistance. Also, there will be lots of chances for volunteers.**

**Because, whom of is born retarded. When old enough, to apply! My corporation wants to pull in Casino's approval for stating I would like to start I will be able to use casino winnings for a donation; me and my volunteers; after a strategic planned evening for us; or myself only; as a group to go out and after choosing a Casino; just as they do with free play; for me; the winnings will be used as donations; for women.**

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets remaining shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the

federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
