ARTICLES OF INCORPORATION OF

BILL AND MARILYN DICKINSON CHARITABLE FOUNDATION, INC.

In compliance with the requirements of Florida Statute Chapter 617, the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a Not For Profit Florida corporation.

ARTICLE I

The name of the Corporation shall be: BILL AND MARILYN DICKINSON CHARITABLE FOUNDATION, INC.

ARTICLE II

The street address of the principal office of the Corporation is: 7 Indian River Avenue, Unit 406, Titusville, FL 32796. The mail address is the same.

ARTICLE III

- 1. The purpose for which the Corporation is organized and formed is for charitable and educational purposes to provide scholarships for students who need financial assistance to learn a trade and attend a trade school, and to provide distributions to The Boys and Girls Club and other such charitable groups that help children and families in North Brevard County, Florida. The corporation, as part of its charitable purposes, may also make distributions to other organizations that stialify as exempt organizations under Section 501(c) (3) of the Internal Revenue corresponding section of any future federal tax code. The Corporation shall exist in perpetuity until dissolved.
- 2. The assets of the Corporation are dedicated to the charitable purhoses described in Paragraph 1, above.
- 3. Upon dissolution of the Corporation, the assets of the Corporation Hall be distributed to and for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code or shall be distributed to the federal government or to a state or local government for a public purpose. Any such assets not so distributed shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization(s) as said court shall determine, which are organized and operated exclusively for such purposes.
- 4. No part of the net earnings of this Corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in

furtherance of the purposes set forth in Paragraph 1, above. No part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

5. Furthermore, notwithstanding any other provision of these articles, this Corporation shall not engage in any activities or exercise any powers that are not permitted to be carried on by a Corporation exempt from the federal income tax under Section 501(c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

ARTICLE IV

The initial board of directors shall consist of no less than three members. This number may be increased or decreased from time to time in accordance with the Corporations' Bylaws but shall never be less than three. The manner and method in which the directors are elected and appointed shall be stated in the Bylaws.
