ARTICLES OF INCORPORATION OF Mogul Makers Foundation, Inc. A FLORIDA NONPROFIT CORPORATION

ARTICLE I NAME

The name of the corporation shall be: Mogul Makers Foundation, Inc.

ARTICLE II PRINCIPAL OFFICE
