

## Articles of Incorporation of REIMAGE CHURCH Inc.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: To provide and maintain a church to worship God ALMIGHTY, to minister the HOLY WORD, to promote Christian spirit and to do all other acts in compliance with the teachings of our Lord and Savior, JESUS CHRIST. The church's mission: "Transforming lives on earth to be in harmony with heaven" (Matthew 5:13-16. To deepen the spiritual life among its members so that all members seek to attain the highest state in their Christian experience as true worshipers of God. To ordain, Apostles, Prophets, Evangelists, Pastors, Teachers, and deacons (nesses) who are divinely called and qualified for the perfecting of the saints for the work of ministry, for the edifying of the Body of Christ (Eph. 4:11-13) to minister to the poor and destitute (James 2:15-16).

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of this document, the corporation shall not carry of many other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are section of any future federal tax code.

Upon the dissolution of this corporation, assets remaining shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
