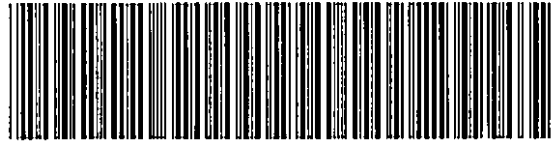

ARTICLES OF INCORPORATION OF EmpowerHer Up, Inc.

ARTICLE I

The name of the nonprofit corporation is **EmpowerHer Up, Inc.**

ARTICLE II CORPORATE PURPOSES

The purposes for which the Corporation is organized and operated are exclusively for charitable purposes and educational within the meaning of Section 501©(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States Internal Revenue law.

The Corporation's charitable and educational goals shall be met primarily by its commitment to aid services throughout the Florida community but not limited to the following:

EmpowerHerUP Inc vision is to empower, inspire, and encourage women to become whole, balance, self-reliant, self-sufficient, and confident to live out their lives to its full potential without becoming or remaining a victim to domestic abuse.

EmpowerHerUP Inc is to bring Awareness, to provide Assistance and Advocacy to victims and survivors of domestic abuse.

- a) Provide assistance and connect women to community resources to help navigate them through housing, the court system and strategize for their safety.
- b) Provide an advocacy program that offer self-help groups for women that are currently in a domestic abusive relationship and/or women who are survivors but still feel trapped and unable move forward.
- c) Create a list of community partnerships for victims and survivors.
- d) Host an annual Awareness Event.
- e) To provide a translational safe house for women and their children.

ARTICLE III LIMITATIONS

1. At all times the following shall operate as condition restricting the operation and activities of the corporation not qualifying as exempt under Section 501©(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, nor to any Directors or officers of the corporation, nor to any other private persons, excepting solely such reasonable compensation that the corporation shall pay for services actually rendered to the corporation, or allowed by the corporation as a reasonable allowance for authorized expenditures incurred on the corporation.

2. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office; and
3. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501©(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended.
4. The corporation shall not lend any of its assets to any officer or director of this corporation (unless such loan program is regularly conducted as part of the activities of the organization and the qualification of the individual to participate in same is determined by a panel comprised solely of non-Board members), or guarantee to any person the payment of a loan by an officer or director of this corporation.

ARTICLE IV DIRECTORS/MEMBERS

The corporation should have no members. The management and affairs of the corporation shall be at all times under the direction of a Board of Directors as define in the corporation bylaws.

ARTICLE VI MANAGEMENT OF CORPORATE AFFAIRS

The number of directors may be increased or decreased from time to time by a majority of the directors, but at no times shall there be fewer than four (4) directors of the Corporation.


