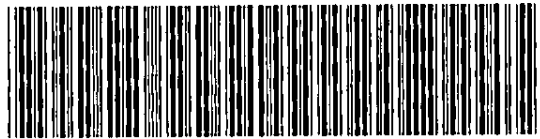

**ARTICLES OF INCORPORATION**  
**OF**  
**HANDS OF HOPE MEDICAL MISSION, INC.**  
a Florida Not For Profit Corporation

**THE UNDERSIGNED**, for the purpose of forming a not for profit corporation under the Florida Not For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

**ARTICLE I**  
**NAME**

The name of this corporation is HANDS OF HOPE MEDICAL MISSION, INC. The principal place of business is 1040 Gulf Breeze Parkway, Suite 200, Gulf Breeze, Florida 32561. Mailing address is 1040 Gulf Breeze Parkway, Suite 200, Gulf Breeze, Florida 32561.

**ARTICLE II**  
**DURATION**

The duration of this corporation is perpetual.

**ARTICLE III**  
**PURPOSE**

The corporation is a not for profit corporation under Chapter 617, Florida Statutes. The corporation is not formed for pecuniary gain or profit, direct or indirect, to itself or its members, directors or officers. No part of the income or assets of the corporation is distributable to or for the benefit of its directors or officers. The corporation is organized, and shall be operated exclusively for charitable purposes to provide access to musculoskeletal care globally in underserved communities through collaborative partnerships, outreach initiatives, and effective resource management. The corporation is organized to do such other things as are incidental to the foregoing or necessary, implied, helpful, or desirable in order to accomplish the foregoing. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any activity not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3), of the Internal Revenue Code.

**ARTICLE IV**  
**REGISTERED OFFICE AND AGENT**

**BOARD OF DIRECTORS**

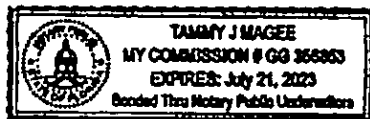

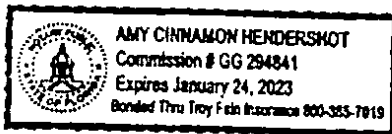
