Pursuant to the provision of Sections 617.1002 and 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment to its Articles of Incorporation:

1. The name of the Corporation is OSPREY VILLAGE CONDOMINIUM ASSOCIATION, INC. (the "Corporation").
2. The date of filing of the original Articles of Incorporation of the Corporation was September 1, 2021, document number N21000010418.
3. Article 1 of the Corporation's Articles of Incorporation is hereby amended to read in its entirety as follows:

"ARTICLE 1

NAME

The name of the corporation shall be **OSPREY PARK CONDOMINIUM ASSOCIATION, INC.** For convenience, the corporation shall be referred to in this instrument as the "Association", these Articles of Incorporation as the "Articles", and the By-Laws of the Association as the "By-Laws".

4. Article 2 of the Corporation's Articles of Incorporation is hereby amended to read in its entirety as follows:

"ARTICLE 2

PURPOSE

The purpose for which the Association is organized is to provide an entity pursuant to the Florida Condominium Act, Chapter 718, Florida Statutes, as it exists on the date hereof (the "Act") for the operation, administration and management of that certain condominium located in Osceola County, Florida, and known as OSPREY PARK, A CONDOMINIUM (the "Condominium") wherein the Association is designated as the "Association."

5. Pursuant to Article 12 of the Articles, the Amendment was duly adopted by a unanimous vote of all the Unit Owners and Board of Directors.

6. The foregoing Amendment to Articles of Incorporation for Osprey Village Condominium Association, Inc. was adopted on the 11th day of August 2022.
