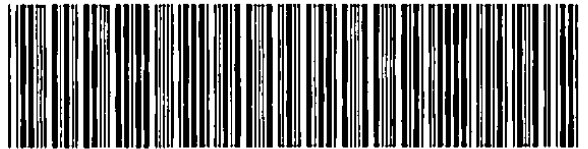

The corporation is not for profit and a public benefit corporation.


