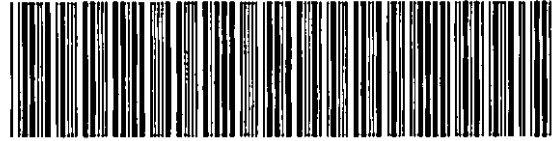

**ARTICLES OF INCORPORATION**

**OF**

**EDWARD & FRANCIS BECKLEY SCHOLARSHIP FUND, INC.**

**ARTICLE I - NAME**

The name of the Corporation (which is hereinafter called Corporation) is

**EDWARD & FRANCIS BECKLEY SCHOLARSHIP FUND, INC.**

**ARTICLE II – PRINCIPAL OFFICE ADDRESS**

The principal office and mailing address is 4505 River Close Boulevard, Valrico, FL 33596.

**ARTICLE III - PURPOSES**

The purposes for which the Corporation is organized are to engage in any lawful act or activity for which a non-stock corporation can be organized under the General Corporation Laws of the State of Florida.

Notwithstanding any other provision of these articles of incorporation, this Corporation shall not engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation, which shall include the following:

- (1) To provide scholarships for high school seniors and college students;
- (2) To promote, enlist, and coordinate the cooperation and involvement of public and private service agencies, educators and educational institutions, and governmental entities for the programs sponsored by the Corporation;
- (3) To solicit, contract for and receive public and private contribution appropriations in the form of financial and personal assistance;
- (4) To make and alter bylaws, not inconsistent with its Articles of Incorporation or with the laws of the State, and/or under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, for the administration and regulation of the affairs of the Corporation;

- (5) To indemnify any director or officer or former director or officer of the Corporation, against any expenses actually and necessarily incurred by him in which he is made a party by reason of being or having been such director or officer, except in relation to a proceeding for negligence or misconduct in the performance of a duty;
- (6) To have and exercise all powers necessary to effect any of the purposes for which the Corporation is organized; and
- (7) The Corporation shall have and exercise all of the powers and rights now or hereafter conferred by the laws of the State of Florida, it being the intention that the purposes set forth in each of the paragraphs of this Articles of Incorporation, shall in no way limit or restrict by reference to or inference from the terms of these Articles of Incorporation or of any amendment thereto.

#### **ARTICLE IV – MANNER OF ELECTION**

The method of election of directors shall be stated in the Bylaws.

#### **ARTICLE VI – REGISTERED AGENT**

The name and Florida street address of the registered agent is Arthur Sullivan, 4505 River Close Boulevard, Valrico, FL 33596. The registered agent of the Corporation is Arthur Sullivan, whose address is 4505 River Close Boulevard, Valrico, FL 33596. Said resident agent is a citizen of the State of Florida and actually resides therein.

#### **ARTICLE VII – IRS 501(c)(3) TAX EXEMPTION PROVISIONS**

Said organization is organized exclusively for charitable, educational, and religious purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

### **Prohibition Against Private Inurement**

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its directors, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

### **Limitation of Activities**

No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

## **ARTICLE VIII - DISSOLUTION**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purpose or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

## **ARTICLE IX - AMENDMENT**


The Corporation reserves the right to make from time to time any amendments of its charter, which may now, or hereafter is authorized by law.






