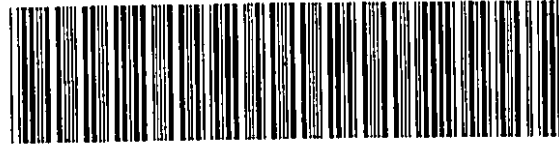

ARTICLE OF INCORPORATION A NONPROFIT, FLORIDA CORPORATION

ARTICLE I – CORPORATE NAME

EVERY NEEDS OUTREACH MINISTRY, INC.

ARTICLE II – CORPORATE NATURE

This is a nonprofit corporation, organized solely for general charitable purposes pursuant to the Florida Corporations Not for profit Florida Law set in Part I of Chapter 617 of the Florida Statutes.

The corporation vision is “to provide assistance to our local and national community, and to encourage a sense of unity and love for all” (Matthew 25:37-40). We are to assist individuals in areas of food, clothing, shelter, training, education, ministry, counseling and unity. We seek to work with agencies and businesses to help provide these essentials of life in gaining the ability to reconcile relationships with their families. This reconciliation will occur by men and women regaining power over their life controlling problems such as drugs, alcohol, gambling, emotional dysfunctions, social dysfunctions, or any substance and/or behavior that they cannot stop in spite of the negative consequences created in their life.

This corporation is organized exclusively as a charitable Christian organization, which will help people create new lives for their families through a spiritual and clinical approach to recovery. Every Needs Outreach Ministry, Inc. will provide travel ministry services as well as; family reconciliation services by, the making of and distribution of information through radio, print media, forming self-help groups for groups and individuals that qualify under section 501 (c) (3) of the Internal Revenue Code, or any corresponding section of any future federal tax code.

ARTICLE III – GENERAL AND SPECIFIC PURPOSE

Section One **EVERY NEEDS OUTREACH MINISTRY, INC.** Is organized and shall be operated exclusively for charitable, religious, Educational and scientific purpose, including, for such purpose, the making of distributions to organizations that qualify as exempt Organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, community development and other related purposes, including, but not limited to, sponsoring, organizing, administering, enhancing and operating activities for the benefit of Escambia County & City of Pensacola, Florida and surrounding communities.

Section Two. **EVERY NEEDS OUTREACH MINISTRY, INC.** Is a not-for-profit corporation organized under Chapter 617, Florida Statutes. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its directors or officers, except to the extent permissible under the Articles of Incorporation and Bylaws, under law and under 26 U.S.C.A. § 501(c)(3) of the Internal Revenue Code. No private individual shall have any vested right, interest or privilege in or to the assets, income, or property of the Corporation and no part of the income or assets of the Corporation shall be distributable to or for the benefit of private individual, except to the extent permissible under the Articles of Incorporation, Bylaws, under law and under 26 U.S.C.A. § 501(c)(3) of the Internal Revenue Code.

ARTICLE IV - COMENCEMENT AND DURATION

The corporation is to commence its corporate existence on the date of subscription and acknowledgement of these articles of incorporation and shall exist perpetually thereafter until dissolved according to law.

ARTICLE V - BOARD OF DIRECTORS

All corporate powers shall be exercised by and under the authority of, and business and affairs of the corporation shall be managed under the direction of board of directors.

The corporation shall have FIVE (5) directors initially. The number of directors may thereafter be increased or decreased from time to time in accordance with the bylaws of the corporation.


ARTICLE IX – DISTRIBUTION OF ASSETS

ARTICLE X - The Incorporator


