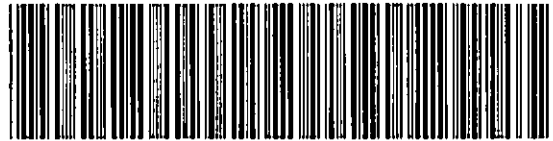


However, this time we hope that all requirements have been completed as stated in your last letter dated August 1, 2021 N°: 221A0001823.


